Dear Colleagues

Investigations have determined that for the markets listed above, extended idle periods in very hot ambient climates with the air conditioning in operation, can cause the throttle position sensor to fail resulting in diagnostic trouble code (DTC) P0121 on vehicles up to 2005MY or P2135 being stored on 2005MY vehicles onwards, with the vehicle going into limp home mode and the restricted performance indicator lamp displayed on the instrument pack.

This action is being completed to remedy a condition that is predominantly found in the unique operating conditions of the markets listed above.

The affected vehicles are highlighted in Table 1 below.

Appendix 1 – Workshop Procedure

1	Install a new throttle body (see TOPIx Workshop Procedure, section: 303-04 (19.70.04).
2	Turn the ignition 'ON' then 'OFF' (to allow the vehicle adaptions to be reset). Start the engine and allow to idle for 3 minutes, and then turn the engine 'OFF'.
3	CAUTION: Main And CAUTION: CAU
	Connect an approved battery charger/power supply to the vehicle.
4	Connect IDS to the vehicle and begin a new diagnostic session, by entering the correct VIN for the current vehicle.
5	Confirm vehicle details and select 'Diagnosis' session type.
6	Select the following symptoms: 'Powertrain - Engine system - Engine performance' and then 'Continue'.
7	Run the 'Complete vehicle - Clear all stored diagnostic trouble codes' candidate from the 'Recommendations' tab.
8	Follow all on-screen instructions to clear diagnostic trouble codes.
9	When the task is completed, exit the current session.
10	Disconnect IDS and the battery charger/power supply.
